TO ALL WHOM THESE PRESENTS MAY CONCERN: Lois Drexel

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto The South Carolina Society for the Prevention of Cruelty to Animals (Known as the Greenville Humane Society) (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Four thousand five hundred and no/100ths-----DOLLARS (\$ 4,500.00 ),  
 with interest thereon from date at the rate of 9 per centum per annum, said principal and interest to be repaid:  
 in monthly installments of \$100.00, including principal and interest at the rate of Nine (9) percent per annum, the first payment being due November 9, 1974 and a like payment being due on the 9th day of each month thereafter until paid in full.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:  
 "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the northwestern side of Sidney Street, being shown as Lot no. 8 on a plat of the estate of J. M. Perry, dated May, 1923, prepared by R. E. Dalton, recorded in Plat Book F at Page 127 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Sidney Street at the joint front corner of Lots 8 and 9 and running thence with Lot 9, N 31-30 W 150 feet to an iron pin at the joint rear corner of Lots 8 and 9; thence N 58-30 E 50 feet to an iron pin at the joint rear corner of Lots 7 and 8; thence with Lot 7, S 31-30 E 150 feet to an iron pin on the northwestern side of Sidney Street; thence with said Street, S 58-30 W 50 feet to the point of beginning.

This is the same property conveyed to the Mortgagor herein by the Mortgagee by deed to be recorded herewith.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties here'to that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
