TO ALL WHOM THESE PRESENTS MAY CONCERN:

Carol S. Fine (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-Two Thousand Four Hundred Ninety-One and 35/100-----DOLLARS

(\$ 32,491.35), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is fourteen years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, lying on the northern side of Edwards Road near the City of Greenville, being shown as Lot 37 on a plat of Botany Woods, Section 1 recorded in the RMC Office for Greenville County, South Carolina in Plat Book QQ at Page 78 and being more particularly described as follows:

BEGINNING at an iron pin on the northern side of Edwards Road at the front corner of Lot 38 and running thence with the line of said lot, N. 5-01 E. 185 feet to an iron pin; thence N. 11-58 W. 87.6 feet to an iron pin; thence S. 76-30 W. 110 feet to an iron pin at the rear corner of Lot 36; thence with the line of said lot, S. 9-55 W. 225 feet to an iron pin on the northern side of Edwards Road; thence with the northern side of Edwards Road, S. 79-20 E. (incorrectly stated as S. 70-20 E. on deed recorded in Deed Book 891 at Page 471) 56.7 feet to a point; thence continuing with the northern side of said road, S. 82-12 E. 93.3 feet to the beginning corner.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
