All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of Enchanted Circle, being known and designated as Lot No. 15 on a plat of ENCHANTED FOREST, made by Carolina Engineering and Surveying Company, dated February 18th, 1963, recorded in the RMC Office for Greenville County, S.
