"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on South Carolina State Highway No. 14, Gilder's Creek, Adams Mill Road (Old S. C. Highway No. 14) Roberts Road, and Bethel Road, (S.C. Highway No. 48) in Austin Township known as HOLLY TREE PLANTATION, all of which tracts are herein described for ease of reference as the Bannon-McNamara property, the Roberts property, the Poinsett Lands, Inc. property, the First Webb property, the Jones property and the Second Webb property, all of which are more fully described on Schedule A attached hereto, incorporated herein by reference and made a part hereof as though fully set forth, subject, however, to those certain excluded lots and tracts described in Schedule B attached hereto, incorporated herein by reference and made a part hereof, and further subject to the additional terms, conditions, and provisions incorporated into this mortgage set forth in Schedule C attached hereto and incorporated herein by reference and made a part hereof as though fully set forth.
