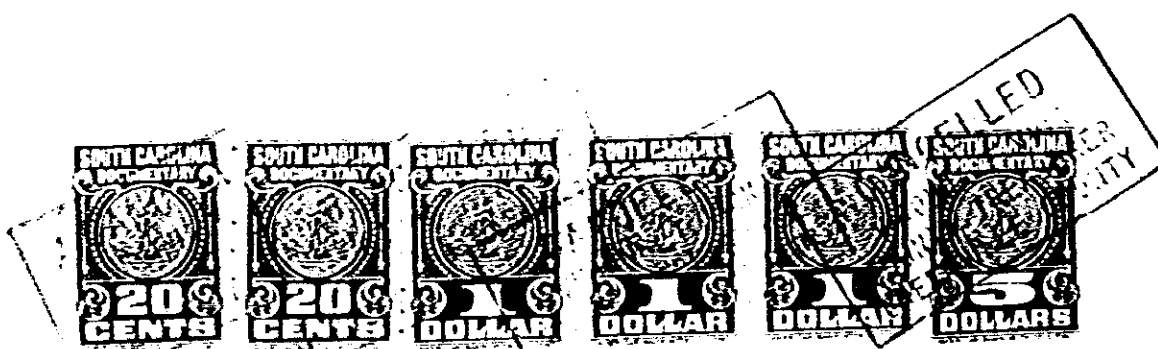
Greenville, S. C. , hereinafter called the Mortgagor, is indebted to
