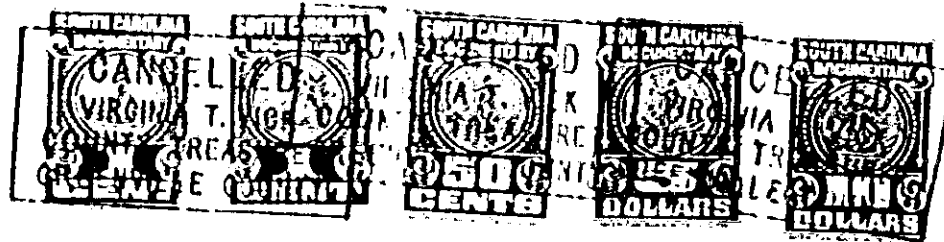

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot No. 133 of Forrester Woods Sub-division, Section Two, according to that plat prepared of said sub-division by R. B. Bruce, Reg. Surveyor, March 17, 1973 and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 4 X, at page 64, and according to said plat having the following courses and distances, to-wit:

Beginning at a point on the edge of Crepe Myrtle Court, joint front corner of lots 91 and 133, and running thence with said Court, N. 11-13 E. 110 feet to a point on said Court, joint front corner of lots 133 and 134; thence running with the common line with lot 134, S. 78-47 W. 150 feet to a point; thence, S. 11-13 W. 110 feet to a point, joint rear corner of lots 133 and 91; thence running with the common line with lot 91, N. 78-47 W. 150 feet to a point on the edge of Crepe Myrtle Court, the point of beginning.
