and payable as follows:

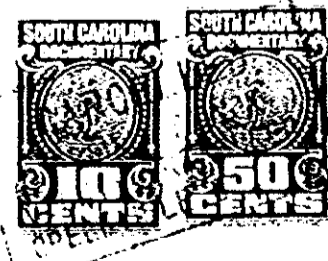
due and payable in full, one (1) year from date

BEGINNING AT AN IRON PIN ON THE Southern edge of the right of way for Jones Road at the
Southeastern corner of the premises herein described and running thence with the
Southern edge of the right of way for Jones Road S. 84-20 W. 360.5 feet to an iron pin;
thence with the line of property now or formerly of A. Davis N. 5-00 W. 904 feet to an
