

LAND DESCRIPTION: Mortgage from Center, Inc. to The Citizens and Southern National Bank of South Carolina, January 28, 1975:

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying on the west side of Augusta Road, containing 1.35 acres, more or less, according to plat made by G. A. Ellis, Surveyor, November 7, 1945, as follows:

BEGINNING at an iron pin on the west side of Augusta Road, corner of property of George M. Owen, and running thence with Owen's line, S. 66 W. 627.6 feet to an iron pin; thence S. 28-0 E. 100 feet to an iron pin; thence N. 77 E. 582 feet to an iron pin on the west side of Augusta Road; thence with the west side of Augusta Road, N. 1-25 W. 100 feet to an iron pin, the point of beginning.

ALSO: ALL that piece, parcel or lot of land in Greenville Township, Greenville County, South Carolina, lying on the west side of Augusta Road, containing 1.18 acres, more or less, and being more fully described, according to a plat made by G. A. Ellis, Surveyor, November 6, 1945, as follows:

BEGINNING at an iron pin on the west side of Augusta Road, joint corner of Algernon Toy Sullivan, and running thence with Sullivan line, S. 64-30 W. 664 feet to an iron pin; thence S. 28-08 E. 80 feet to an iron pin; thence N. 66 E. 627.6 feet to an iron pin on the west side of Augusta Road; thence with the west side of Augusta Road, N. 1-25 W. 80 feet to an iron pin, the point of beginning.
