Parcel No. 1- All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina on the western side of Owens Road, being shown and designated as Lot No. 23 on Plat of Lorena Park, which plat is recorded in the R.M.C. Office for Greenville County in plat Book "SS", at page 171, and having the following metes and bounds to wit:

BEGINNING at an iron pin on the western side of Owens Road at the joint corner of said lot and property owned by B. G.
