MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Jimmy M. Bridges, of Greenville County,

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagoe) in the full and just sum of

Forty-Four Thousand, Eight Hundred and No/100----- (\$ 44,800.00 __)

Dollars as evidenced by Mortgagor's promissory note of even date herewith which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

Three Hundred Sixty-Two and 96/100----(5 362.96) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal bilances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 29 years after date, and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and impaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortzagee, or any stipulations set out in this insuffage, the whole anisant due thereunder shall, at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortzagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortzagoe to the Mortzagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortzagor in hand well and truly paid by the Mortzagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortzagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of last, with all improvements therein, or breafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 192 of Section 4 of Forrester Woods Subdivision according to a plat thereof prepared by R. B. Bruce, Surveyor, dated April 8, 1974 and recorded in the R. M. C. Office for Greenville County in Plat Book 4-R at Page 68, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Royal Oak Road at the joint front corner of Lots 191 and 192, and running thence with the southern side of said road, N. 63-36 E. 105 feet to an iron pin at the intersection of Royal Oak Road and Rollingwood Road; thence with the curvature of said intersection, the chord of which is S. 77-20 E. 38.6 feet, to an iron pin on the western side of Rollingwood Road; thence with the western side of Rollingwood Road, S. 38-16 E. 109.6 feet to an iron pin; thence with the line of Lot No. 192, S. 72-10 W. 150.4 feet to an iron pin at the joint rear corner of Lots 190, 191 and 192; thence with the joint line of Lots 191 and 192, N. 30-58 W. 109.4 feet to the point of beginning.
