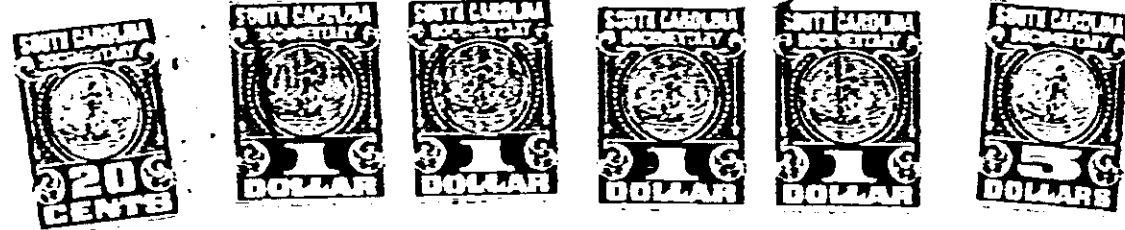
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as all of Lot 108 and a 15 foot strip from the northern side of Lot 109 on plat of Homestead Acres, Section II, recorded in Plat Book XX at page 143 and having the following courses and distances:

BEGINNING at an iron pin on the southern side of Hampshire Drive at the joint front corner of Lots 107 and 108 and running thence S. 02-10 E. 105 feet to an iron pin in rear of line of Lot 109; thence S. 87-50 W. 174.1 feet through Lot 109 to an iron pin on the eastern side of Havenhurst Drive; thence N. 02-10 W. 80.0 feet with the eastern side of Havenhurst Drive to an iron pin at the southeastern corner of intersection of Havenhurst Drive and Hampshire Drive; thence N. 42-50 E. 35.3 feet with curve of said intersection; thence N. 87-50 E. 149.1 feet with the southern side of Hampshire Drive, to point of beginning.
