TO ALL WHOM THESE PRESENTS MAY CONCERN:

ELIZABETH S. HUNTER (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twelve Thousand and No/100----- DOLLARS

(\$12,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Cleveland Township, in Pioneer Park (also known as Lakemont Colony) and being known as Lot No. 209 and 210 as shown on Map No. 2, Pioneer Park Property, on plat of record in the RMC Office for Greenville County, S. C., in Plat Book G, page 82, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Hagood Road at the joint front corner of Lots Nos. 208 and 209, and running thence along the joint line of said lots S. 2-14 W. 175 feet to an iron pin at a 20-foot alley; thence along the north side of said alley N. 87-56 W. 200 feet to an iron pin at the joint rear corner of Lot Nos. 210 and 211; thence along the joint line of said lots N. 2-34 E. 158 feet to an iron pin on the south side of Hagood Road; thence along the south side of Hagood Road N. 87-12 E. 200 feet to the point of beginning.

This mortgage is recorded to correct that certain mortgage given by Elizabeth S. Hunter to Fidelity Federal Savings and Loan Association which is of record in the RMC Office of Greenville County, S. C., in REM Book 1164, page 663; this mortgage changes description from Lots 223, Pioneer Park Property, to Lots 209 and 210, Pioneer Park Property.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
