All that certain piece, parcel, or lot of find with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, Centry of Greenville, in the City of Greenville, on the north-eastern side of Webster Street and having, according to survey prepared by Webb Surveying & Mapping Co., dated March 7, 1973, the following metes and bounds, to-wit:

Beginning at an iron pin on the northeastern side of Webster Street at the joint front corner of Lots 5 and 6 of Oakland Heights (as shown on plat thereof recorded in Plat Book C, at Page 147), and running thence along the joint line of said Lots N. 32-38 E. 150.0 feet to an iron pin; thence S. 69-26 E. 60.00 feet to an iron pin; thence S. 71-56 E. 64.5 feet to an iron pin; thence S. 11-38 W. 266.9 feet to an iron pin on the northeastern side of Webster Street; thence along the northeastern side of Webster Street N. 29-08 W. 176.6 feet to an iron pin at the corner of Lot 6; thence continuing along the northeastern side of said Street N. 69-01 W. 60.00 feet to the point of beginning.
