(hereinafter referred to as Mortgagor) SEND(S) GREETING:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of State Highway no. 101 about three miles Northwest of Greer, in Oneal Township, and being more particular described as follows, to-wit: Beginning at a Nail in said highway and running thence S.1-05 E.248 feet to an old Iron Pin, thence N.81-05 W.120 feet to an Iron Pin, thence N.8-12 E.244.2 feet to a Nail in said highway (Iron Pin back on line at 20 feet), thence with said highway S.81-05 E.80 feet to the beginning point. This being the same property which was conveyed to Marvin F. Holcombe, Jr. by W. Dennis Smith by deed recorded in the R. M. C. Office for said County in Deed Book 815, page 366. And being the same property which was conveyed to mortgagor herein by Marvin F. Holcombe, Jr. by deed which will be recorded forthwith in the said office.
