Twenty-eight Thousand Six Hundred and no/100-----DOLLARS

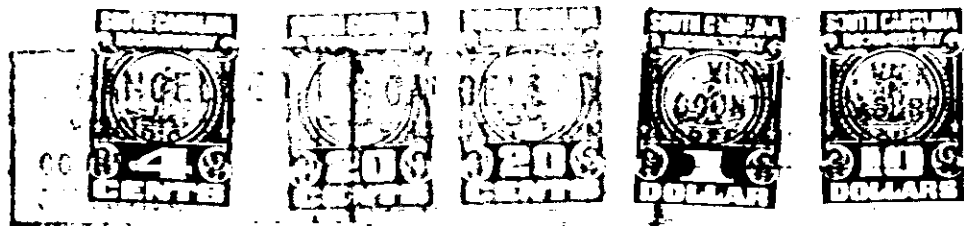

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Simpsonville, being shown and designated as lot 35 on a plat entitled "Section 1, Powderhorn", dated July 26, 1973, revised March 1, 1974, prepared by Piedmont Engineers and Architects, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4X at page 95, and according to a revised plat of Lots 33, 34 and 35 by Robert P. Spearman recorded in Plat Book 5D at page 68 having the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Canebreak Lane N. 82-47 W. 142.9 feet to an iron pin joint rear corner of Lots 34 and 35; thence N. 04-14 E. 93.3 feet to an iron pin joint rear corner of Lots 35 and 36; thence S. 66-45 E. 110 feet to an iron pin on the western side of Canebreak Lane; thence with said lane S. 10-47 W. 20 feet to an iron pin; thence S. 11-21 E. 20 feet to an iron pin; thence S. 35-43 E. 20 feet to an iron pin; thence S. 61-15 E. 25 feet to an iron pin the point of beginning.
