*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, shown as Lot 23 on plat of Haselwood, Section Two, Revision of Lots 23 and 24 recorded in Plat Book 5K at page 86 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on Mellwood Drive at the joint front corner of Lots 22 and 23 and running thence along the joint line of said lots, S. 08-32 W. 287.4 feet to an iron pin at the rear of said lots; thence along the rear of Lot 23, N. 79-10 W. 123.8 feet to an iron pin at the rear corner of Lots 23, and 24; thence along the joint line of said lots, N. 12-06 W. 290.25 feet to an iron pin on Mellwood Drive; thence along said Drive, S. 84-12 W. 226.2 feet to the point of beginning.
