TO ALL WHOM THESE PRESENTS MAY CONCERN: DOUGLAS R. GRIER AND

DEBORAH E. GRIER

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Thirty-one Thousand Five Hundred and No/100 ----- DOLLARS

(\$ 31,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southern side of Drewry Road, being shown and designated as Lot Number 28 on a plat of Avondale Forest, Section 2, recorded in the RMC Office for Greenville County in Plat Book "BBB" at Page 37 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the Southern side of Drewry Road, at the joint corner of Lots 27 & 28, and running thence, S 39-21 E 128.8 feet to a point; thence running, S 48-44 W 150 feet to a point on the Northeastern side of Crafton; thence running along Crafton, N 41-16 W 85 feet to a point; thence following the curve of the intersection of Crafton and Drewry Road, the chord of which is N 0-46 E, 37 feet to a point on the Southern side of Drewry Road; thence running along said Drewry Road, N 43-18 E 100 feet to a point; thence continuing along Drewry Road, N 35-32 E 30 feet to the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee for the term of the guaranty policy the sum of 1/48th of 1% of the original amount of this loan in payment of the mortgage guaranty insurance covering this loan and on his failure to pay it, the mortgagee may advance it for the mortgagor's account and collect it as part of the debt secured by the mortgage. The mortgagors agree to maintain guaranty insurance in force until the loan balance reaches 75% or less of the original appraisal or sales price, whichever is less, and the mortgagee may apply for mortgage guaranty insurance to comply with the above, through the mortgage guaranty insurance company insuring this loan, and that the mortgagor agrees to pay to the mortgagee, annually, as premium for such insurance 1/4 of 1% of the principal balance. Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or then in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, exist- and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
