"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate. lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot 19 on plat of Crescent Terrace, recorded in the RMC Office for Greenville County in Plat Book E at Page 137 and having, according to said plat, and a more recent plat entitled "Property of Mary Frances McMurria and James Austin McMurria" by Dalton & Neves, Eng. dated August 17, 1959, the following courses and distances, to-wit:

BEGINNING at an iron pin on the northern side of Crescent Avenue at the joint front corner of Lots Nos. 19 and 20, said pin being N. 84-40 E. 140 feet from the northeastern intersection of Crescent Avenue and Capers Street and running thence with the northern side of Crescent Avenue N. 84-40 E. 80 feet to an iron pin, joint front corner of Lots Nos. 18 and 19; thence with the joint line of said lots N. 5-41 W. 289.7 feet to an iron pin; thence along the rear line of Lots Nos. 7 and 8 S. 89-07 W. 80.2 feet to an iron pin, joint rear corner of Lots Nos. 19 and 20; thence along the joint line of said lots S. 5-41 E. 295.9 feet to the beginning corner.
