TO ALL WHOM THESE PRESENTS MAY CONCERN: James Austin McMurria and

Mary Frances McMurria (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Ten Thousand and No/100----- DOLLARS

(\$ 10,000.00-----) as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, being known and designated as Lot 19 on plat of Crescent Terrace, recorded in the RMC Office for Greenville County in Plat Book E at Page 137 and having, according to said plat, and a more recent plat entitled "Property of Mary Frances McMurria and James Austin McMurria" by Dalton & Neves, Eng. dated August 17, 1959, the following courses and distances, to-wit:

BEGINNING at an iron pin on the northern side of Crescent Avenue at the joint front corner of Lots Nos. 19 and 20, said pin being N. 84-40 E. 140 feet from the northeastern intersection of Crescent Avenue and Capers Street and running thence with the northern side of Crescent Avenue N. 84-40 E. 80 feet to an iron pin, joint front corner of Lots Nos. 18 and 19; thence with the joint line of said lots N. 5-41 W. 289.7 feet to an iron pin; thence along the rear line of Lots Nos. 7 and 8 S. 89-07 W. 80.2 feet to an iron pin, joint rear corner of Lots Nos. 19 and 20; thence along the joint line of said lots S. 5-41 E. 295.9 feet to the beginning corner.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
