NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of Greenville All that certain piece, parcel or lot of land with all of the improvements, Situate, lying and being in the State of South Carolina, County of Greenville near the City of Greenville and being more particularly described as Lot No. 103 Section 1, as shown on a plat entitled "Subdivision of Village Houses, P.O. Poe Hg. Co., Greenville, S.C." made by Dalton & Hoves, July 1960, and recorded in the R.M.C. Office for Greenville County in Part Book "I" at pages 26 to 30 inclusive. According to said plat, the within described lot is also known as No. 25 Third Avenue, and fronts thereon 7.2 Feet.

TO HAVE AND TO HOLD all and singular the real estate described above unto said Mortgagee, its successors and assigns forever.
