

ALSO all that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, situate at the northwestern corner of the intersection of Wilbanks Street and Owens Street and being shown as Lot 1 on plat of Central Realty Corporation recorded in plat book Q at page 147 in the R.M.C. Office for Greenville County and more fully described as follows:

Beginning at an iron pin on the intersection of Wilbanks Street and Owens Street and running thence with the northern side of Wilbanks Street S. 79-45 W. 61 feet to an iron pin at corner of Lot 2; thence with line of Lot 2 N. 10-15 W. 150 feet to an iron pin; thence N. 79-45 E. 61 feet to an iron pin on Owens Street; thence with the western side of Owens Street, S. 10-15 E. 150 feet to the point of beginning.
