"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, being shown as Lots 3 and 4 on a plat of Mountain View Acres recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book TT at page 3, and having such metes and bounds as shown below:
