KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of one dollar and other considerations, receipt whereof is hereby acknowledged. The Federal Land Bank of Columbia, the owner and holder of the security instrument hereinafter referred to and of the note(s) thereby secured does, subject to the conditions hereinafter stated, hereby release from the lien of that certain security instrument from

to The Federal Land Bank of Columbia, dated the 8th day of September, 1972, and recorded in the public records of Greenville County, State of South Carolina in Mortgage Book 1249, at page 627, the following described property, to-wit:

All that certain piece, parcel or tract of land in Greenville County, State of South Carolina, being shown on plat of survey of Byron F. Stone, dated 4-30-75, prepared by Aaron M. Thompson, Registered Land Surveyor, and having according to said plat, the following metes and bounds, to wit:

Beginning at a nail and cap in the center of Sullivan Road, which nail and cap is located approximately 1816 feet Southeast of Georgia Road, and running thence with property, now or formerly of Ansel Kellett, N. 53-59E., 375.5 feet to an iron pin; thence with property, now or formerly of B. F. Stone S. 36-01 E., 120 feet to an iron pin; thence continuing with line of said Stone property, S. 53-59 W., 393.28 feet to a nail and cap in center of Sullivan Road; thence with the center line of Sullivan Road, N. 23-08 W., 60 feet to a nail and cap; thence continuing with the center line of Sullivan Road, N. 32-03 W., 61.63 feet to the beginning corner.

PROVIDED, HOWEVER, that the security of The Federal Land Bank of Columbia as described in the aforesaid security instrument shall, in all respects, except as to the premises hereinbefore described, be preserved and protected and that the lien of said security instrument, except as hereby released and discharged, shall remain in full force and effect and the terms, conditions and covenants thereof and of the note(s) thereby secured, shall remain unchanged.
