(\$38,000.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-nine years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 147 on plat of Coach Hills, recorded in Plat Book 4X at page 86 and refiled in Plat Book 4X at page 94 and having the following courses and distances:

BEGINNING at an iron pin on Coach Hills Drive at the joint front corner of Lots 148 and 147 and running thence along a 15 foot trail between said lots, N. 43-19 W. 161.45 feet to an iron pin at the rear of Lot 147; thence along the rear of said lot, S. 39-56 E. 162.92 feet to an iron pin at the rear corner of Lots 147 and 146; thence along the joint line of said lots, S. 66-49 W. 170.85 feet to an iron pin on Coach Hills Drive; thence along said drive, the following courses and distances: N. 34-10 W. 53.88 feet and N. 43-09 W. 41.20 feet to the beginning point.
