BEGINNING at an iron pin on the Southern side of Georgtown Circle at the joint front corner of Lots 32 and 33 as shown on aforesaid plat and running thence along and with the joint property line of said two lots S. 31-03 E. 99.3 feet to an iron pin; thence S. 33-10 W. 94.58 feet to an iron pin; thence N. 36-20 W. 42.1 feet to an iron pin; thence N. 38-04 W. 40 feet to an iron pin at the joint rear corner of Lots 33 and 34 as shown on said plat; thence running along and with the joint property line of said lots N. 1-30 E. 105 feet to an iron pin on the Southern side of Georgtown Circle; thence running along and with the curve of the Southern side of Georgtown Circle, the chord of which is S. 68-59 E. 25 feet to a point on the Southern side of Georgtown Circle; thence continuing along the curve of the Southern side of Georgtown Circle, a chord of which is N. 81-55 E. 25 feet, to the point of beginning.

TOGETHER with all and singular the Rights, Members, Hereditaments, and Appurtenances, to the said Premises belonging, or in anywise incident or appertaining.
