BEGINNING at an iron pin on the Southern side of Bellamy Court at the joint front corner of Lots 57 and 58 as shown on said plat and running thence along and with the joint property line of said two lot lines S. 22-33 W. 93.7 feet to an iron pin; thence N. 71-08 W. 95.5 feet to an iron pin at the joint rear corner of Lots 58 and 59 as shown on said plat; thence running along and with the joint property line of said two lots N. 27-00 E. 70.4 feet to an iron pin located on the Southern side of cul-desac for Bellamy Court; thence running along and with the curve of said cul-desac the chord of which is N. 89-45 E. 30 feet; thence continuing along the curve of said cul-desac, the chord of which is N. 60-49 E. 19.7 feet to an iron pin on the Southern side of Bellamy Court; thence running along and with Southern side of Bellamy Court S. 70-23 E. 50.0 feet, to the point of beginning.

TOGETHER with all and singular the Rights, Members, Hereditaments, and Appurtenances, to the said Premises belonging, or in anywise incident or appertaining.
