NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 33 on plat of Section 1, Trollingwood recorded in the RMC Office for Greenville County in Plat Book 4R at page 12 and having the following courses and distances:

Beginning at an iron pin on the eastern side of Shadowmere Drive, joint front corner of Lots 34 and 33 and running thence with the eastern side of said road, N. 10-37 E. 80 feet to an iron pin, joint front corner of Lots 33 and 32; thence with the common line of said lots, N. 63-05 E. 268.4 feet to an iron pin; thence S. 13-27 E. 119.0 feet to an iron pin; thence S. 27-11 W. 101.2 feet to an iron pin; thence S. 44-39 W. 99.7 feet to an iron pin, joint rear corner of Lots 33 and 32; thence with the common line of said lots, S. 65-10 W. 182.3 feet to an iron pin on the eastern side of Shadowmere Drive, the point of beginning.
