NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of Greenville

All that piece, parcel or lot of land in Bantt Township, Greenville County, South Carolina, on the west side of Old Grove Road, and known and designated as the eastern end of Lot No. 4, according to plot of property of John A. Carson made by J. Coke Smith, Surveyor, in February, 1946, and designated as follows:

Beginning at a stake, joint corner of Tracts Nos. 4 and 5, said plat and running thence with the joint lines of said lots N. 74-30 W. 450 feet; thence S. 15-30 E. 100 feet to line of Tract No. 3; thence N. 74-30 E. 450 feet to a stake on the west side of Old Grove Road; thence with said Road N. 15-30 W. 100 feet to the point of beginning.
