KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of One Dollar and other valuable consideration, receipt and sufficiency whereof are both hereby acknowledged, FIDELITY FEDERAL SAVINGS & LOAN ASSOCIATION, the owner and holder of the security instrument hereinafter referred to and of the note thereby secured does, subject to the conditions hereinafter stated, hereby release from the lien of that certain security instrument from AMERICAN SERVICE CORPORATION OF SOUTH CAROLINA, dated October 16, 1972, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Real Estate Mortgage Book 1253 at page 365, the following described property, to-wit:

All that piece, parcel or lot of land, situate, lying and being in the City of Simpsonville, County of Greenville, State of South Carolina, being shown and designated as Lot No. 22, on plat entitled "Section I, Powderhorn", dated July 26, 1973, most recently revised March 1, 1974, prepared by Piedmont Engineers and Architects, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4-X at page 95, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point on the eastern side of the cul-de-sac of Vicksburg, at the joint front corner of Lots Nos. 21 and 22, and running thence, along the joint line of said lots N. 12-00 E. 180 feet to a point, at the joint rear corner of Lots Nos. 21 and 22; thence, along the line of Lot No. 22 and the common area of Powderhorn, S. 46-59 E. 193.0 feet to a point at the joint rear corner of Lots Nos. 22 and 23; thence, along the joint line of said lots, S. 62-00 W. 160 feet to a point on the eastern side of the cul-de-sac of Vicksburg; thence, along said street, the following courses and distances, N. 36-15 W. 25 feet, N. 64-52 W. 25 feet to a point at the joint rear corner of Lots Nos. 21 and 22, the point and place of beginning.

Provided, however, that the security of FIDELITY FEDERAL SAVINGS & LOAN ASSOCIATION, as described in the aforesaid security instrument shall, in all respects, except as to the premises hereinbefore described, and hereby released and discharged, shall remain in full force and effect, and the terms, conditions and covenants thereof and of the note thereby secured, shall remain unchanged.
