TO ALL WHOM THESE PRESENTS MAY CONCERN: EDD ELROD, STEVE ELROD

and GATHY ELROD (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Ten Thousand Eight Hundred and no/100----- DOLLARS

(\$10,800.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty (20) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northwestern corner of Hellene Street and Alma Avenue being shown and designated as Lot No. 6 of Block B on plat of property of J. Ed Means prepared by W. H. Riddle, dated January, 1940 recorded in Plat Book J at Page 186 and being described, according to said plat, more particularly, to-wit:

BEGINNING at an iron pin on the northern side of Hellene Street at the corner of Lot No. 5 and running thence N. 29-43 W. 175 feet to an iron pin; thence N. 60-17 E. 81.2 feet to the southwestern side of Alma Avenue; thence with said avenue, S. 65-33 E. 185.6 feet to an iron pin; thence with the curve of the intersection of Alma Avenue and Hellene Street in a southerly direction 27.3 feet to an iron pin; thence along the northern side of Hellene Street S. 60-17 W. 177.7 feet to the point of beginning.
