WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

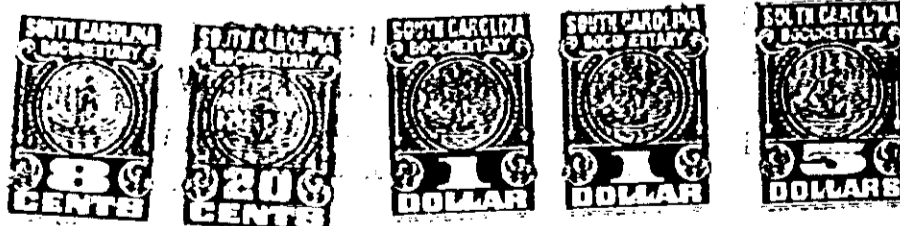

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and being a portion of Lot 155, Sunny Slopes Subdivision, Section Two, according to that certain plat prepared of said subdivision prepared by C. O. Riddle, Surveyor, February 8, 1971 and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4R, at Page 67, and having the following courses and distances to-wit:

BEGINNING at a point on the edge of Wendfield Drive, joint front corner of Lots 154 and 155 and running thence with the common line of said lots N. 70-50 E. 151.8 feet to a point; thence, S. 15-30 E. 89.4 feet to a point in the common line of lots 155 and 156; thence running with the common line of said lots, S. 74-30 W. 150 feet to a point on the edge of Wendfield Drive; thence running with the edge of Wendfield Drive, N. 15-30 W. 52 feet to a point; thence continuing with said Drive, N. 18-36 W. 27.7 feet to a point on the edge of aid Drive, the point of beginning.
