TO ALL WHOM THESE PRESENTS MAY CONCERN:

JOHN CARROLL HIPPS AND MARTHA JEAN PAINTER HIPPS
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of TEN THOUSAND AND 00/100-----

DOLLARS (\$ 10,000.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

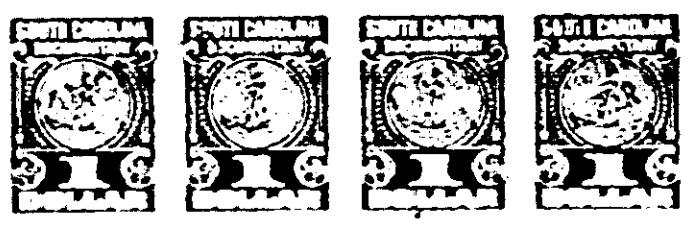

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, containing 1.4 acres, in accordance with plat prepared by C. O. Riddle, entitled "Property of Nora Jirmon", dated June 22, 1978 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point in Shuffletown Road, at the corner of property now or formerly of Nora Jirmon and running thence N. 81-50 E., crossing over an iron pin at 22 feet for a total distance of 241.1 feet to an iron pin; thence S. 81-50 E., 22.1 feet to an iron pin; thence S. 81-50 W., 220 feet to an iron pin in Shuffletown Road; thence with said Road, N. 81-52 W., 124 feet to a point; thence continuing with said Shuffletown Road, N. 81-10 W., 124.2 feet to the point of beginning.
