State of South Carolina:

ALL that piece, parcel or lot of land, together with all buildings and improvements thereon, situate, lying and being on the northern side of Pinnacle Drive, in Greenville County, South Carolina, being known and designated as Lot No. 31 on a plat of GREEN FOREST, Section C, made by Woodward Engineering Co., dated March 1957, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK, page 87, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Pinnacle Drive at the joint front corner of Lots Nos. 30 and 31 and running thence along the common line of said lots, N. 2-52 W., 274.7 feet to an iron pin; thence S. 86-26 W., 20 feet to an iron pin at the joint rear corner of Lots Nos. 31 and 32; thence with the common line of said lots, S. 27-12 W., 215.1 feet to a concrete monument on the northern side of Pinnacle Drive; thence along the northern side of Pinnacle Drive, S. 56-23 E., 16 feet to a concrete monument; thence continuing along the northern side of Pinnacle Drive, S. 58-29 E., 139 feet to an iron pin, the point of BEGINNING.



To Have and note that unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appartenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate in the event this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any easements and restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.

UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, prepayment and late charges as provided in the Note, and the principal of and interest on any Future Advances recurred by this Mortgage.
