NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being Lot 42 and a strip of Lot 41 as shown on plat of Property of Central Development Corporation, recorded in Plat Book BB at Pages 22 and 23 in the R.M.C. Office for Greenville County, and having the following metes and bounds:

Beginning at an iron pin on the northern side of Bellwood Drive at the joint front corner of Lots 42 and 43, and running thence S. 63-24 W. 90 feet to an iron pin in the front line of Lot 41; thence N. 19-55 W. 251.1 feet to an iron pin in the rear line of Lot 41; thence N. 39-19 E. 82.4 feet to an iron pin; thence 23-53 E. 281.8 feet to the beginning corner.
