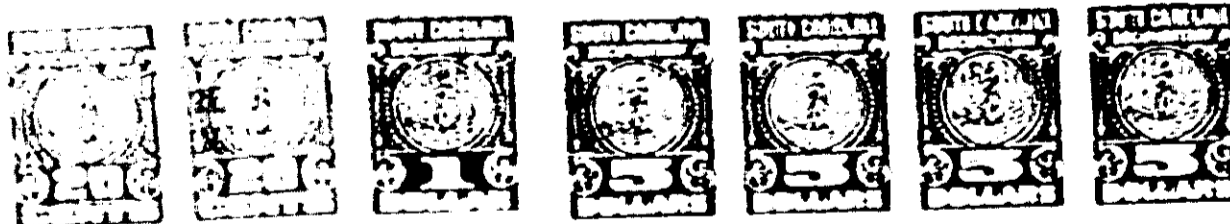

NOW KNOW ALL MEN That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, on the northeasterly side of Silver Creek Road, being known and designated as Lot No. 291 on plat entitled "Map No. 1, Section One, Sugar Creek" as recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book 5-D, at page 18, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Silver Creek Road, said pin being the joint front corner of Lots 290 and 291, and running thence with the common line of said lots, N 40-45-00 E 149.5 feet to an iron pin at the joint rear corner of Lots 290 and 291; thence N 49-08-30W 125 feet to an iron pin on the woutheasterly side of a 10 foot walkway; thence with the southerly edge of said walkway, S 40-45-00 W 149.30 feet to an iron pin on the northeasterly side of Silver Creek Road; thence with the northeasterly side of Silver Creek Road, S 49-15-00 E 125 feet to an iron pin at the point of beginning.
