WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

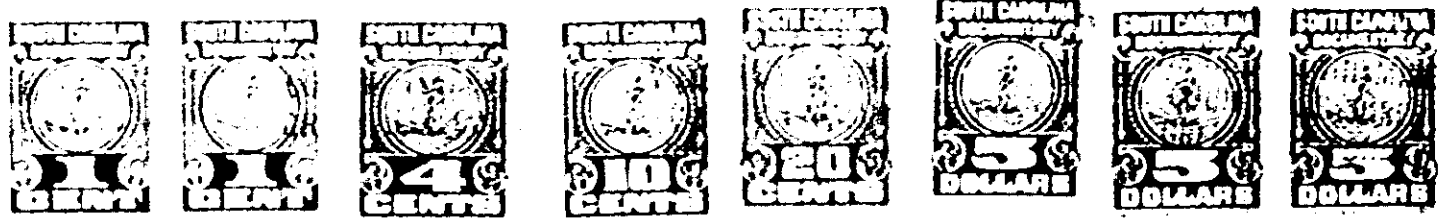

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of McDaniel Avenue in the City of Greenville, being known and designated as Lot No. 25 on Map 2 of CLEVELAND TERRACE made by Dalton & Neves in May, 1931, revised August, 1941, and recorded in the R. M. C. Office for Greenville County in Plat Book K, at pages 98 and 99, and being described as follows:

BEGINNING at an iron pin on the west side of McDaniel Avenue at the joint front corner of Lots Nos. 24 and 25, and running thence with line of Lot No. 24, N 75-55 W 200 feet to an iron pin; thence S 12-43 W 70 feet to an iron pin; thence with the line of Lot No. 26, S 75-55 E 200 feet to an iron pin on the west side of McDaniel Avenue; thence with the west side of McDaniel Avenue, N 12-43 E 70 feet to the beginning corner.
