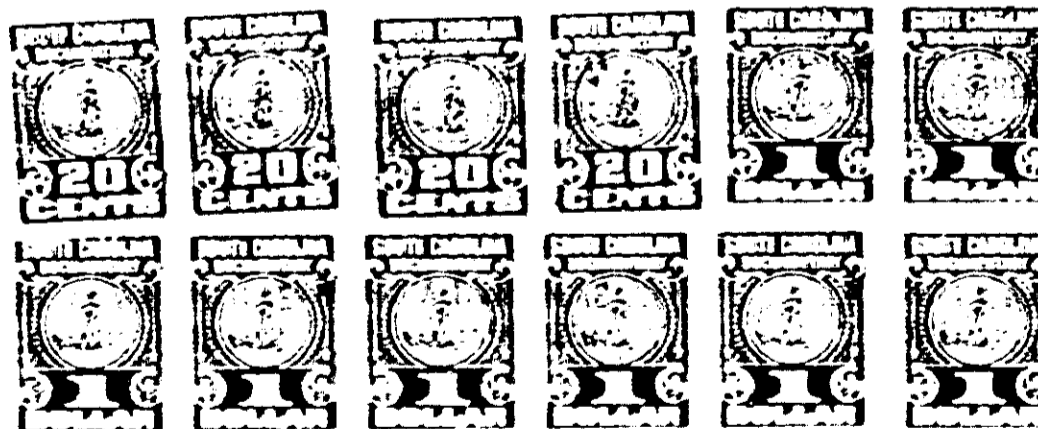

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 129 as shown on a plat of Map of Riverdale prepared by Dalton & Neves in July, 1957, recorded in the Office of the RMC for Greenville County in Plat Book KK at Page 107, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Riverview Drive at the joint front corner of Lots 128 and 129, running thence with the Southern side of Riverview Drive S. 73-09 E. 100 feet to an iron pin at the joint rear corner of Lots 129 and 130; running thence with the common line of said two lots, S. 16-51 W. 211.9 feet to an iron pin; running thence N. 76-01 W. 100.06 feet to an iron pin at the joint rear corner of Lots 129 and 128; thence with the common line of said two lots, N. 16-51 E. 216.9 feet to the point of beginning.
