MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

HARRY L. HUFFMAN

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CLARA B. HEWELL

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirteen Thousand and no/100

-----DOLLARS (\$ 13,000.00),
with interest thereon from date at the rate of $8 \frac{1}{2}$ per centum per annum, said principal and interest to be repaid: in monthly installments of One Hundred Twelve and 82/100 (\$112.82) Dollars beginning on the 1st day of September, 1975 and on the first day of each month thereafter until paid in full. There shall be no prepayment of principal or interest for a period of five (5) years from date hereof.

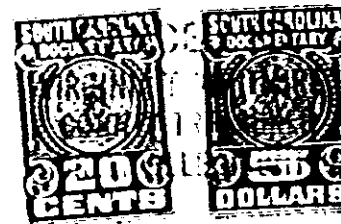
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns: "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of East North Street, in the City of Greenville, according to survey made by Dalton & Neves in February 1951, recorded in Plat Book T at Page 482 and is described as follows:

BEGINNING at a stake at the northeastern corner of East North Street and an unnamed thirty foot street, and running thence with the northern side of East North Street N. 69-33 E. 70 feet to a stake at corner of property of Mrs. Bessie Rozier; thence with the line of said lot, N. 20-13 W. 199 feet to a stake on a 15-foot alley; thence with the southern side of said alley, S. 69-49 W. 70.3 feet to a stake on an unnamed thirty foot street; thence with the eastern side of said street, S. 20-11 W. 200 feet to the beginning corner.

Less, however, a 15-foot alley way deeded to the City of Greenville in Deed Book 459 at Page 365.
