To All Whom These Presents May Concern: We, John Earl Oliver and
Shirley M. Oliver

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

Fifteen Thousand and no/100
DOLLARS (\$ 15,000.00), with interest thereon from date at the rate of eight and one-half (8½) per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville located about twelve miles North of Greer, South Carolina, being shown and designated on a plat of property being made for Edgar Morrow by W. N. Willis, Eng., on September 19, 1974, to be recorded herewith, as having the following courses and distances to-wit:

BEGINNING at a nail in the center of the intersection of Jug Factory Road and Wingo Road and running thence along the Lance Estate Boundary N. 0-10 W. 540.5 feet to an iron pin, thence along the Boundary of Edgar Morrow S. 62-05 E. 319 feet to an iron pin, thence continuing along the course of S. 62-05 E. 20 feet to a nail in the center of Jug Factory Road, thence along the center of Jug Factory Road S. 43-30 W. 100 feet to a nail thence S. 31-18 W. 300 feet to a nail, thence S. 39-50 W. 85 feet to the beginning corner, and containing according to said plat 1.7 acres, more or less.

THIS conveyance is subject to the right-of-way of the Highway Dept. covering Jug Factory Road.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
