MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

William C. Harris and Constance H. Harris
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto John G. Cheros and Larry R. Patterson
(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Four Thousand Nine Hundred Nine-
teen and 90/100----- DOLLARS (\$ 4,919.90---),
with interest thereon from date at the rate of nine per centum per annum, said principal and interest to be repaid:

Due on or before 60 days from date.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

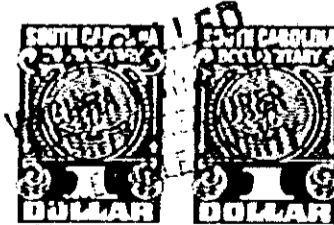
All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 72 on plat of Stratford Forest, recorded in Plat Book KK at page 89 and having such courses and distances as will appear by reference to said plat.

Also:

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 57 on plat of Buxton recorded in Plat Book 4N at pages 2, 3 and 4 and having such courses and distances as will appear by reference thereto.

The interest of John G. Cheros in the balance due under this mortgage is 57 1/2% and the interest of Larry R. Patterson is 42 1/2%.
