That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Spartanburg, lying and being on the South side of Maple Drive, off State Highway No. 101, South of the City of Greer, being shown and designated as lot number FORTY FOUR (44) on a plat of property made for Joseph L. Campbell by H. S. Brockman, surveyor, dated August 16, 1952 and recorded in plat book 28 pages 396 and 397, Spartanburg County R. M. C. Office, and has the following metes and bounds, to wit:
