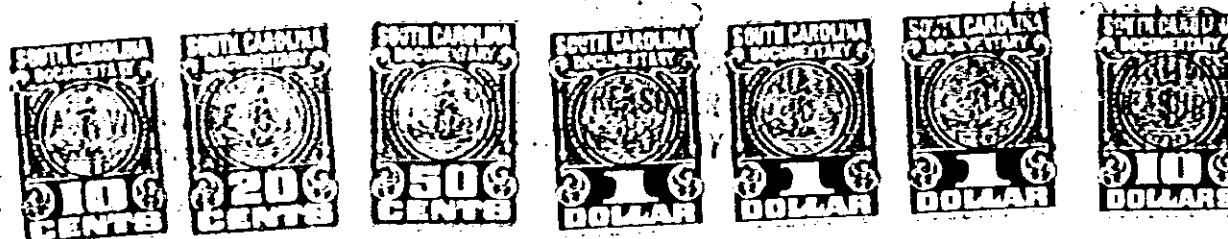

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, Has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot #76, on plat of Section No. II, Old Mill Estates, made by Piedmont Engineers and ARchitects, July 15, 1972 and recorded in the RMC Office for Greenville County in Plat Book 4R at Page 22. According to said plat, the property is more fully described as follows:

BEGINNING at an iron pin on the turn-around of Burlwood Court at the joint front corner of Lots #76 and #77 and running thence along the joint line of said lots N. 42-19 E. 140.7 feet to an iron pin at the joint corner of Lots 76, 77, 82 and 83; thence with line of lots 83, 84 and 85 S. 86-13 W. 330 feet to an iron pin at the corner of Lots 86 and 75; thence with line of Lot 75 S. 57-43 E. 194.6 feet to an iron pin on turn-around of Burlwood Court; thence with the curve of said turn-around N. 48-55 E. 40.0 feet to an iron pin; thence continuing with curve of turn-around S. 83-46 E. 40.0 feet to an iron pin, the point of beginning.
