WHEREAS, the Mortgagor is well and truly indebted unto Associates Financial Services Co., Inc. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

Four Thousand Six Hundred Eight and No/100 ----- DOLLARS (\$ 4,608.00 ),

with interest thereon from date at the rate of eight per centum per annum, said principal and interest to be repaid: maturity

in 36 equal monthly installments of \$128.00 each, the first of said installments being due November 14, 1975, and a like installment due on the 14th day of each month thereafter until paid in full.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot Number 43 on plat of Cherokee Park, made by Brodie and Bedell, Engineers, dated July 1913, recorded in Plat Book C at Page 96 of the RMC Office for Greenville County.

This is the same property conveyed to the Mortgagors by deed recorded in Deed Book 938 at Page 395 of the RMC Office for Greenville County.

This mortgage is junior in lien to that certain mortgage in favor of Greer Federal Savings and Loan Association, recorded in Mortgage Book 1325 at Page 611 of the RMC Office for Greenville County.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
