DOLLARS (\$ 10,400.00), with interest thereon from date at the rate of **nine** per centum per annum, said principal and interest to be paid as therein stated, and

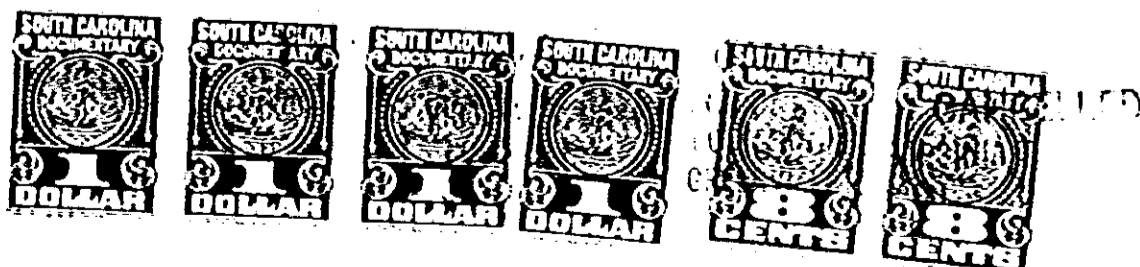

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing approximately 1.04 acres, more or less, as shown on plat by Terry T. Dill, dated February 20, 1956, and having the following metes and bounds, to-wit:
