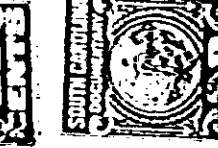
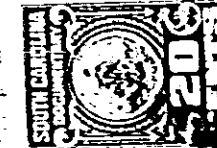
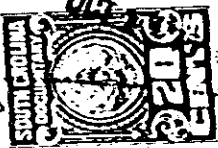

This Mortgage, made this 8th day of October 1975 by and between Kenneth D. and Libby Baldwin hereinafter referred to as Mortgages, and Dial Finance Company of South Carolina hereinafter referred to as Mortgagee, witnesseth:

Whereas, Mortgages are indebted on their promissory note of even date in the sum of \$ 4392.00 payable to Mortgagee and evidencing a loan made to Mortgages by Mortgagee, which said note is payable in monthly installments, and according to the terms thereof payment in advance may be made in any amount at any time, and default in making any monthly payment shall, at the option of the holder of said note, and without notice or demand, render the entire sum remaining unpaid on said note at once due and payable.

NOW KNOW ALL MEN, that in consideration of said loan and to further secure the payment of said Note and also in consideration of three dollars (\$3) to the Mortgages in hand well and truly paid by Mortgagee at and before the sealing and delivery of these presents, receipt whereof is hereby acknowledged, the Mortgages hereby

grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate, situated in the County of Greenville and State of South Carolina, to-wit: **All that piece parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying and being in the southeastern side of Ford Circle and being known and designated as Lot No 39 on a plat of ENOREE ACRES SUBDIVISION plat of which is recorded in the RMC Office for Greenville County, in plat Book "UUU" at page 181, and having such metes and bounds as shown thereon, references to said plat being made for a more complete description. This conveyance is subject to all restrictions, setback lines, roadways, zoning ordinances, easements and right of ways appearing on the property and/or of record. This is a portion of that property conveyed to the Grantors herein by deed recorded in the RMC Office for Greenville County in Deed Book 837 at page 34.**

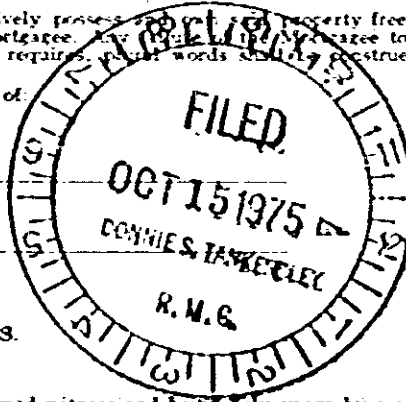
To have and to hold, with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, unto said Mortgagee, provided always, and this instrument is made, executed, sealed and delivered upon the express condition that if the said Mortgages shall pay in full to the said Mortgagee the above described Note according to the terms thereof, then this Mortgage shall cease, determine and be void, otherwise it shall remain in full force and virtue. Upon default in making any payment of said Note when the payment becomes due, then the entire sum remaining unpaid on said Note shall be due and payable by the exercise of the option of acceleration above described, and this Mortgage may be foreclosed as provided by law for the purpose of satisfying and paying the entire indebtedness secured hereby.

The Mortgages covenant that they exclusively possess and enjoy the property free and clear of all encumbrances except as otherwise noted, and will warrant and defend the same against all persons except the Mortgagee. They agree to enforce any of its rights or remedies hereunder shall not be a waiver of its rights to do so thereafter. Whenever the context so requires, the words shall be construed in the singular.
