WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Sixty-four Thousand and no/100----- DOLLARS

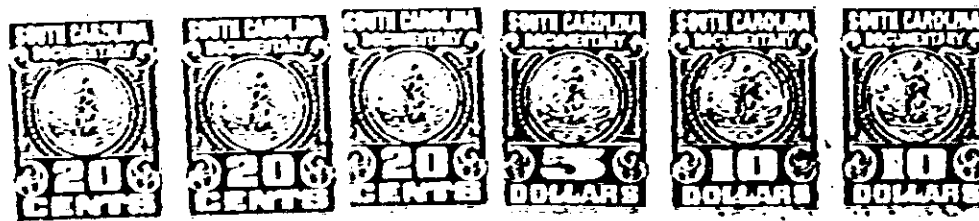
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

near Rutherford Road, known as Lot Four (4) on a plat of the property of "Mountain Ridge Industrial Park" made by Freeland and Associates, dated 6/14/74 and revised 9/9/74 and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the right of way corner of Lot Two (2), and running thence with said right of way N. 17-35 E. 162 feet to an iron pin; thence S. 72-25 E. 254 feet to an iron pin; thence S. 17-35 W. 162 feet to an iron pin; thence N. 72-25 W. 254 feet to the beginning corner.

Together with the non-exclusive use of the right of way referred to above and shown on said plat.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
