All that certain piece, parcel or lot of land, situate, lying and being on the Western side of Front Street in Bates Township, County of Greenville, State of South Carolina, being shown and designated as Lot No. 2 on a map of Laurie Forest near Penfrew, South Carolina, Greenville County, made by J. C. Hill, surveyor, Dated January 5, 1951, revised May, 1960, revised November, 1960, recorded in the R. M. C. Office for Greenville County, S.
