Gail Thompson Cody, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of ----- Seventeen Thousand Five Hundred and no/100 ----- DOLLARS

(\$ 17,500.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township being shown and designated as all of Tract No. 3 on plat of "Property of L. E. Thompson", prepared by Terry T. Dill, RLS, dated November 6, 1967, recorded in Plat Book 4H at Page 165 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the west side of S. C. Highway No. 290, corner of Tract No. 4 and 3 and running thence with the common line of said lots S. 79-30 W. 380 feet to an iron pin; thence N. 12-36 W. 211 feet to an iron pin; thence N. 72-45 E. 380 feet to an iron pin on west side of said highway; thence with said highway S. 16-48 E. 147 feet to pin; thence with said highway S. 8-30 E. 110 feet to the point of beginning and containing 2.06 acres, more or less, this being the home place of L. E. Thompson.
