Gloria W. Phillips (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-Nine Thousand Eight Hundred Fifty and no/100-----DOLLARS

(\$ 39,850.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of Gavins Point Road being shown and designated as Lot # 439 on a plat of Section V, Del Norte Estates prepared by Piedmont Engineers and Architects dated May 23, 1973 recorded in Plat Book 4R at Page 17 in the R. M. C. Office for Greenville County and being described according to said plat more particularly to-wit:

BEGINNING at an iron pin on the northern side of Gavins Point Road at the joint front corner of Lots 439 and 440 and running along the common line of said lots N. 03-09 W. 148.5 feet to an iron pin at the joint rear corner of said lots; thence along the rear line of Lot 439 N. 87-00 E. 95 feet to an iron pin at the joint rear corner of Lots 439 and 438; thence along the common line of said lots S. 03-08 E. 150.9 feet to an iron pin at the joint front corner of said lots on the northern side of Gavins Point Road; thence along said road S. 88-30 W. 95 feet to an iron pin, the point of beginning.
