All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

on the northeastern side of Crestline Road, near the City of Greenville, being shown and designated as Lot No. Twenty One (21) of Section A on plat of HILLANDALE HEIGHTS made by T. M. Welborn, Surveyor, October 7, 1950, recorded in the RMC Office of Greenville County, S.C., in Plat Book "Y" at Page 113, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Crestline Road at the joint front corner of Lots No. 20 and 21, Section A, and running thence with line of Lot No. 20 N 41-36 E 238.7 feet to an iron pin; thence running S 64-42 E 140.5 feet to an iron pin; thence with line of Lot No. 29, Section B, S 53-43 W 294.2 feet to an iron pin on the northeastern side of Crestline Road; thence running with the northeastern side of Crestline Road N 41-24 W 79.5 feet to the beginning corner.
